Vide reference 1st and 2nd Cited, Orders issued for selection and positioning of Gram Volunteers and Ward Volunteers for delivering Government Services at door step of all eligible households in a transparent and corruption free manner.

It has come to the notice of the Government that some of the Gram Volunteers and Ward Volunteers have relieved in the recent past and Volunteer Clusters / Territorial Units kept vacant / in-charge arrangements made.

APCFSS has developed Web application for positioning of Gram Volunteers / Ward Volunteers newly after consideration of No. of Clusters / Territorial Units created and House Holds mapped through Volunteer Mobile Application from January, 2020 onwards and Number of Volunteers are working at present.

Selection and Positioning of Volunteers to be done as and when vacancy arises using separate Web application developed by APCFSS for the purpose. Login credentials will be communicated separately to access the web application.

Any other mode of Selection and positioning of Volunteer other than Web application Developed by APCFSS will not be considered and shall not be entertained for payment of honorarium to the Volunteers.

It should be ensured that the selection and positioning of Volunteers in the vacancies that have arisen to be strictly done as per the new application developed by the APCFSS.

Therefore, I am requesting all the Collectors to take necessary action for selection and positioning of Gram Volunteers / Ward Volunteers using separate new application developed by APCFSS from 11.04.2020 to 18.04.2020 as the Hon'ble Chief Minister desires to position Volunteers in the vacant clusters on war foot basis.
